THE JUROR

Crista Dix is the Founder and Director of wall space gallery in Seattle, Washington and now in Santa Barbara, California. Starting in this creative field as a photographer, collector and lover of the visual image, Crista decided to put down her camera and utilize her years of business management to help promote photographers and photography. With a background in science, business and creative arts, she has created a gallery space that celebrates artists' vision. She has been a member of numerous panels and discussions, juried creative competitions, most recently for Center for Fine Art Photography in Fort Collins, and has participated in major portfolio reviews across the country in Houston, Portland, Los Angeles, Santa Fe and New Orleans.

HOW TO ENTER

Send the completed entry form with your labeled CD and payment to PCNW, 900 12th Avenue, Seattle, WA 98122 and follow the instructions below.

DEADLINE: Must be received by Friday, October 22nd, 8 pm.

- CD Submission: Images submitted on a CD must be jpgs formatted for a PC. (no DVD's)
- Maximum jpeg size is 10 inches or 1024 pixels in the longest dimension and scanned at 72 ppi.
- The entry fee is \$5 per jpeg. You may submit up to ten images total.
- Each jpeg must be titled with the photographer's name, correlating letter to match the entry form, the title of the image and the year it was taken.
- Example: JohnSmith_A_Untitled_2006.jpg
- You are strongly encouraged to have a PDF file of your artist's statement highlighting your vision or approach. (200 words or less).
- The CD must be labeled with the photographer's name as well as the case it's in.

- You may not submit work that has been shown in past PCNW Members' Exhibitions.
- Materials will not be returned.
- Entry fees are non-refundable.

Images submitted for the juried exhibition will also be considered by our curatorial staff for our Annual Photo Center NW Publication featuring work by our talented members, students, alumni, faculty, staff & volunteers. The publication will launch at the Members' Exhibition Artists' Reception, Dec 3rd, 6-9 PM, 2010.

NOTIFICATION

Selected artists will be notified by phone. A list of the selected artists will be posted at www.pcnw.org in late October.

SUBMISSION OF ACCEPTED WORK

Selected artists will have approximately 4 weeks to prepare their work for delivery for the exhibition due: November 24th. All work must be framed or mounted and have a hanging solution on the backside: such as a wire or wood cleat. The maximum frame size is 32 inches in width. Be sure to label the back of your pieces with your name, title, and phone number. If you are shipping your work we suggest plexiglas rather than glass. Please do not use frame kits that utilize solely glass, clips & string. The Photo Center NW reserves the right to refuse accepted work that differs substantially from the original scan. All works selected for exhibition must be offered for sale at a price determined by the artist. Artists will receive fifty percent of the sold work. Please note that images selected for the show may be used for promotion of the exhibition and PCNW. Photo Center NW will handle your pieces with extreme care once they arrive but will not be held responsible for scratches that already exist, loose frame corners, chipped frames or damage caused during transport & poor packaging. The work will be insured while on our premises; however claims are only made for damage that occurs due to Photo Center accidents, negligence or theft.
